## **POSITION SUMMARY**

Reporting to the Acting Manager, Community Development & Food Security, the Community Development Worker is responsible for supporting the development and coordination of Community Development activities including assisting with the Food Security Program local outreach establishing and maintaining relationships within the service community.

To be eligible, students must:

- Be between 18 and 30 years of age at the start of the employment
- Be a Canadian citizen, permanent resident, or person to whom refugee protection has been conferred under the immigration and Refugee Protection Act 3
- Be legally entitled to work in Canada in accordance with relevant provincial/territorial legislation and regulations
